#### • Parties involved in YZ125 bLU cRU Cup

- Yamaha Motor Europe N.V., (hereinafter referred to as YME), including its branches:
- Youthstream Group, Lda. (hereinafter referred to as Youthstream);
- Fédération Internationale de Motocyclisme (hereinafter referred to as FIM).

#### Involvement of parties

- YME sets the structure and rules for the YZ125 bLU cRU Cup (hereinafter referred to as "Cup"), is the entity responsible for managing the marketing and promotional rights of the Cup and is the entity in charge of the interaction between the stakeholders involved in this project;
- The branches of YME are in charge of the local communication and direct contact with the riders, providing them the bLU cRU welcome pack and sticker kit on the behalf of YME;
- Youthstream is the entity which manages the television rights for the Cup and is as well in charge of organizing the Cup Superfinale inside the Motocross of Nations race event. Youthstream is the stakeholder which establishes direct contact with FIM regarding the Superfinale;
- The licensing for the Superfinale event is under FIM regulations (only European 125 championship or one event European are allowed) and is a responsibility of the rider to request it through the national federation.
- · Structure of the Cup
- Subscriptions

Subscription for participation in the Cup is possible between 7 December 2016 and until 1 March 2017;

#### · National Championships

This Cup will be an integrated part of the national championships, in which the Yamaha riders will have their own ranking, which will be locked by 10 September 2017 for the selection of riders joining the Superfinale;

• Superfinale in Matterley Basin (UK)

The best riders of each national championship will race in a Superfinale which will happen on 1 October 2017 at Matterley Basin, UK and will be part of the main event "Monster energy Motocross of Nations";

## bLU cRU Masterclass

The top 3 riders plus 2 wild cards chosen by a jury from the Superfinale at the Monster energy Motocross of nations will then participate on a multiple day Masterclass with bLU cRU ambassador;

## • EMX 125 2017 ride

The best rider of the Masterclass, chosen by the Yamaha Racing committee/bLU cRU ambassador, will join a Yamaha official EMX125 team as an official rider for the 2018 season.

- · Participation Requirements
- The participation in the Cup is restricted to the national championships in Europe;
- The rider must be fully licensed in their national federation and racing with a Yamaha YZ125 for a championship in an European country;
- In order to participate in the Cup, the rider must have been born between 1 January 2001 and 1 January 2005;
- The rider cannot race more than 5 races in the EMX125 championship during 2017 season;
- It is mandatory for the riders participating in the Cup to use during national championship season, Superfinale and Masterclass, the YZ125 bLU cRU Cup sticker kit provided by YME.

# Insurance

- The insurance for YZ125 bLU cRU Cup is a responsibility of each national federation and, regarding specifically the Superfinale, of FIM;
- The indemnity and liability clauses are set by the insurance included in the FIM and national federation licenses;
- YME and its branches are excluded from any liability in case of accident that causes any injury, permanent disability or death.

## · Attendance at the events

- The riders must be racing on their national championship and are obliged to attend to a minimum of 50% of the races in this championship in order to be able to participate in the Superfinale;
- YME is responsible to define the rider allocation per country and selection of riders for the Superfinale;

 The total amount of 44 riders will be completed following criteria per area:

Group A. Spain / Italy / France / UK / Germany – TTL 20 riders; Group B. The Netherlands / Portugal / Sweden / Norway / Denmark / Finland / Belgium – TTL 15 riders;

Group C. Austria / Switzerland / Greece / Bulgaria / Israel / Poland / Turkey / Ukraine / Latvia – TTL 9 riders;

After registration will be completed the specific riders allocation per country will be defined according to the numbers of registration with the target to offer similar possibility to challenge the Superfinale inside each Group.

The riders who manage to reach the following step in the Cup, are obliged to attend to it, unless prevented as a result of major force (injury, severe health problem). In this case, the rider will be replaced with a reserve rider.

#### Costs

- All the participation costs of this Cup (regarding national championships, Superfinale and Masterclass) will be on the rider/ team responsibility including, but not limited to transport & logistic, bike purchase and usage, parts, mechanical & assistance, licensing for national championship and Superfinale;
- There is no subscription fee for this Cup, including the Superfinale, Masterclass and EMX125 ride (excluding national championship licensing and participation fees defined by the national federation);
- YME will provide a cost-free bLUcRU welcome pack (2/T-shirt, 1/ Hoody, 1/Umbrella, 1/Cap, / Back pack / bLU cRU Sticker Badge) and an exclusive sticker kit for the bike;
- In case the rider requires more bike sticker kits, these should be requested to YME, through yz125blucrucup@yamaha-racing.com and these will be provided for a promotional cost.

#### · Registration Instructions

- To join the YZ125 bLU cRU Cup, it is mandatory to fill in the complete registration form and send it to yz125blucrucup@yamaha-racing.com;
- In order to be considered valid, the form needs to be signed by both rider and one of the parents or legal tutors;
- The rider will then receive a confirmation email from YME and the rider's registration is only confirmed and finalized after this;
- All the information provided by the rider must be under his responsibility, as this will be checked by the national distributors.

## · Cancellation of events

For any reason, and without prior notice, YME reserves the right to cancel the event.

# • EMX125 2018 participation conditions

- The best rider chosen from the Masterclass will be participating in EMX125 championship in 2018 for the Yamaha MJC official team;
- The rider will be fully supported by Yamaha as an official rider under the conditions of a to be agreed contract with YME;
- The rider participating in the EMX125 will have to follow the rules and instructions of YME and the team, including sponsorship agreements.

# Image rights

Rider shall grant or procure the granting, free of charge, to YME the exclusive right to use rider's name, rider's personal racing number design(s), signature, initials, likeness, including photographed portraits, film, video, CD-rom, CD-I and other footage or comments by electronic means of rider, and comments and opinions, in connection with advertisements.

# Applicable law

- By providing all the data, the rider acknowledges YME the right to use the data for registration purposes under the laws of the Netherlands;
- You agree that any disputes in connection with the use of this information or in connection to your participation to the Cup shall be resolved by the competent court of Amsterdam, the Netherlands.
